Refund requests are processed according to the following time restrictions:

- Refund requests received on or before September 30, 2016 will receive a 100% refund
- Refund requests received on or between October 1 and October 14, 2016 will receive a 50% refund
- Refunds cannot be guaranteed for requests received on or after October 14, 2016, or for no-shows at the conference
